

# Live and Local Working Group – meeting minutes

# 2. What's been happening in the wider music industry & regulatory environment that you need to know about?

- Musicians able to use Loading Zones
- Dedicated live music and performance venues granted extra 60 mins trading
- Removing high-risk terminology in reference to Music Festivals
- 26 Nov 2021 The Parliament of New South Wales has voted in favour of a bill that would ensure a minimum payment of \$250 for musicians performing at publiclyfunded events.

### 3. Professional Development workshops

In response to the framing questions:

- i) What does a thriving local music scene look like?
- ii) What things can realistically be changed/adapted/grown/supported to achieve that vision for the Clarence Valley?

Group discussion (+ some written notes) raised many topics including:

- How to provide more avenues for young people to get involved in music, such as rehearsal space / access to equipment / informal hang outs where musicians can jam and make connections in the local industry.
- Educating venue owners / promoters about how gigs work (cheat sheet) and minimum award rates for musicians.
- Better knowledge of local opportunities eg. Live Prawn Productions Inc. underwriting scheme for event promoters.
- Educating audiences about the importance of buying tickets in advance.
- Youth Week high school battle of the bands with industry mentorship & venue buy-in leading to paid gigs.
- Youth Week / Plunge industry conference with panel session followed by 1-2-1 sessions – access wider network, career advice, update local contacts.

- Developing the scene by widening the genres of original music presented spoken word / rap etc
- Women in Music panel session better representation
- How a connected and self-organised local music industry can have far-reaching positive reputational effects on a region also attractive to tourists.
- Using existing infrastructure (eg. musician-managed Facebook groups) to keep the conversation going.

Based on themes arising from the discussion, Niño will invite speakers to the PD Workshop(s) – number and locations budget dependent and ideally situated in Grafton and Yamba.

Timing is mid-Feb, either week before or week after Micro-festivals.

- Clarified performance fees: it's \$161.13 per musician for a maximum 3-hour shift that means if you play for 45 min, each musician is paid \$161.13 (current minimum award rate for musicians).
- Currently no budget for PA rental / engineers, so venues will be asked to contribute.
